The Maritime Gig Festival is the Peninsulas' oldest and largest festival. Thousands of people attend the festival each year. During the Maritime Festival there are numerous activities drawing large crowds, such as evening stage shows, concessions, parade, Fun Run and much more.

DATE: June 7, 2008

SHOWTIME: 10:00 AM to 9:00 PM

LOCATION: On the portions of Harborview located between Pioneer and Rosedale Streets, next to Skansie Brother's Park.

SET-UP TIME: 6:00 a.m.

FEE: \$125.00 for a 10' x 10' space with NO electric hook up. *(Covered spaces not provided- you must provide your own tent.)*

EQUIPMENT: Exhibitors are responsible for whatever exhibit

equipment they require. NO GENERATORS PERMITTED.

DEADLINE: All reservations for exhibition space must be in by April 30, 2008.

Photos and payment in full must accompany the signed registration form!

REGULATIONS:

1. The Maritime Gig Fine Arts & Crafts Committee retains the right to refuse space to market products deemed objectionable. Only original handmade items are to be accepted. No factory made or imports will be accepted. All on-sight activities subject to approval.
2. All display materials are the responsibility of exhibitor. A neat, attractive display is important. Entire display must be inside assigned area. Fire extinguisher must be provided.
3. Each exhibitor is responsible to clean-up area used by exhibitor.
4. No food or drinks are to be sold by exhibitors.
5. No tear down before end of show.
6. Washington State Sales Tax is the responsibility of the exhibitor.
7. No refunds of entry fee after April 1, 2008.
8. No receipt will be sent; your canceled check will be your evidence of acceptance in show.
9. No cars or trucks will be allowed to park on show property.
10. All Exhibitor's vehicles must be in, unloaded, and moved out of exhibit area within 20 minutes.
11. **Proof of Insurance must be provided prior to the event.**
12. **Photos of Product and Display must accompany application.**
