Thank you for your interest in the 2008 Maritime Gig Festival, scheduled for June 7<sup>th</sup>, Gig Harbor, Washington. The following rules apply to all food vendors:

The fee for a 10' x 10' food site is \$195. There is an additional fee of \$75.00 for oversized trailers and vehicles, or ground operators. Space Fees include the nominal use of electric/water and garbage. **Only one vendor per booth is allowed – no split or shared booths.**

If you are selling non-prepackaged food, you must carry public and product liability insurance in the amount of \$1,000,000 (one million dollars) and name the Chamber of Commerce as additional insured. **A copy of the insurance must accompany your Maritime Gig Festival Food Vendor Application.**

**You must provide a fire extinguisher for your booth(s).**

**You must apply for your own Pierce County Health Department Permit. The deadline for your Food Vendor Application and the Health Department Permit is April 2<sup>nd</sup>. Cost for the permit and compliance with Pierce County rules and regulations is your responsibility.**

**Friday: SETUP:**

Enter from Rosedale onto Harborview no earlier than 3:00PM and no later than 6:00PM. Late arrivals will cause cancellation of booth space, which is non-refundable.

Event Schedule enclosed for your operating convenience. Booths will remain up over night.

Parking permissible as assigned by Gatekeeper. *Be sure to put your pass on the dash of your vehicle prior to entering Rosedale and leave it on your dash while parked during the event.*

**NO VEHICLES ON GRASS AREA OF SKANSIE BROTHERS' PARK EITHER DAY**

**Saturday: TEAR DOWN:**

All Vendors stay open for business until 9:00PM.

Breakdown of booths begins at 9:00PM. Breakdowns before that time will result in disqualification for next year's event.

Payment must accompany your Maritime Gig Festival Food Vendor Application. Make checks payable to Maritime Gig Festival. For your convenience we also accept Visa/Master Card (see below).
